4. APPLICATION INFORMATION

- Applications will be attended immediately. Application closing date 20 March 2025
- Approval of application will be attended as soon as possible. Placement of stalls will be assigned according to lay out of the terrain and will be final.
- Market committee's decision is final, no stall will be moved without permission of Market Committee.
- Successful applicants will be notified via email, whereafter all fees are to be paid in full.
- No exhibiter will be allowed without payment of stall.
- No stalls will be allowed to change position without permission.

5. GENERAL INFORMATION

- Exhibitioners are responsible for providing own equipment, tables, chairs, umbrellas, gazebo's
- > The Church will not supply any furniture or equipment.
- > Stall areas are not to be enlarge under any circumstances.
- Provide own black bags for waste. Big black bins will be provided.
- > Stall areas and surrounding areas need to be kept clean at all times.
- > Make use of own gas and generators, if possible, electricity outlets are limited



- No animals allowed.
- > No load music that will disturb other exhibitioners.
- Only one vehicle per Stall will be allowed parking is limited.

6. FOOD STALLS

- Food carts need to comply to all the Dept of Health Regulations and Certifications.
- > All waste products need to be disposed of in black bags and big black bins.
- > All stalls need to be kept clean at all times.
- No open fires will be allowed on the grass or anywhere near buildings and vehicles or where people and children move. No fire or gas equipment are allowed to be left unattended. Safety first. Exhibitioners will be charging penalties and fined if rules are not adhered to.
- Fire extinguishers need to be visible at all food stalls using gas and fire.
- > Fridges and cooler boxes must be used for perishable food. (own)
- > All ash from fires needs to be cold before disposed of.

7. ELECTRICAL OUTLETS

- ❖ Take note that electrical outlets are limited at an extra fee.
- If possible, make use of gas and make sure of safety regulation.
- You may make use of petrol generators.

8. SEKURITY / FIRST AID

• Every stall is responsible for own security and first aid.
